THE POSITION:

The Pennsylvania State Employees' Retirement System (SERS) is seeking two Investment Interns to have the opportunity to work alongside senior investment staff managing the commonwealth's \$30 billion pension fund! While working with the investment team, interns will gain exposure to development and execution of investment strategy across multiple asset classes, which may include equities (stocks), fixed income (bonds), real estate, and private equity.

Interns may also have the opportunity to interact with investment professionals from some of the world's largest institutional money managers, consulting firms, and research groups.

SERS' investment internships include the opportunity for interns to receive their Bloomberg Certification.

DESCRIPTION OF WORK:

Summer internships typically start in late May or early June and end in August. SERS will work with interns to accommodate academic schedules.

Likely assignments include:

- Create and distribute monthly reports summarizing economic indicators and market data
- Monitor and track investment manager performance metrics
- Prepare monthly Pro-Forma Asset Allocation reports for senior investment staff
- Assist with preparation of investment material for SERS board meetings
- Attend and participate in meetings with external investment advisors, internal staff, and SERS board

REQUIRED EXPERIENCE, TRAINING & ELIGIBILITY:

Students who are interested in this SERS internship must meet all of the following requirements:

- Be enrolled at an accredited college or university for summer 2018 or fall 2018
- Be working toward a bachelor's or master's degree in business, economics, finance, or investments
- Be able to earn college credit for the internship
- Carry on overall GPA of 3.0 or higher; 3.4 or higher preferred
- Be available to work 37.5 hours weekly between the hours of 8:00 a.m. and 5:00 p.m. during a normal business week of Monday through Friday
- Submit a cover letter and resume with application

SERS is able to hire individuals in the United States on a student visa under certain conditions. The student must be in a status/category – typically F-1 or M-1 – that does not require sponsorship. The student must be able to produce the required documents establishing identity and employment authorization in accordance with form I-9, Employment Eligibility Verification. The Commonwealth of Pennsylvania participates in the federal E-Verify program.
