> FUNSTON RECOMMENDATIONS UPDATE

MOTION: That the Investment Committee recommend to the State Employees' Retirement Board to direct the SERS' Governance and Personnel Committee to consider taking action at a future meeting to recommend to the Board to amend the SERS Fiduciary Review Policy to remove the term "non-economic" in reference to describing SERS' in-state managers, minority and women-owned programs, etc., which is currently found in the list of topics included in the SERS Fiduciary Review Policy.

➤ BENCHMARKING UPDATE

Jeff Meyer of SERS provided an update on SERS' Strategic Plan peer benchmarking initiative. The Investment Committee concurred with the proposed course of action and SERS' Investment Office will move forward with preparing a combined presentation including each of SERS' primary investment consultants (Callan, StepStone, and NEPC) comparing SERS' manager fees and expenses with each of the consultants' universe of managers and/or investment opportunities.

➤ INVESTMENT COMMITTEE CHARTER REVIEW

Jim Nolan and Chris Houston of SERS provided a review of the Investment Committee Charter. After their review, two motions by the Investment Committee were considered. The below motions were made as follows:

To recommend: (i) to the State Employees' Retirement Board that it approve the amendments to the Investment Committee charter, as set forth in the attached, after receiving input from the Board Governance and Personnel Committee, and (ii) to the Board Governance and Personnel



Committee that it concurs with this Committee's recommendation and so inform the State Employees' Retirement Board.
