1. Call to Order

Prior to the meeting starting, the Board members were informed that the meeting would be recorded with the exception of executive session discussion. At 3:45 p.m., Committee Chair Secretary Thall called the meeting to order.

2. Welcome and Roll Call

Ms. Lynn took roll call stating a quorum was present. The Committee Chair then introduced SERS' new Chief Compliance Officer, Jo Ann Collins, to the Committee members.

3. <u>Approval of Minutes</u>

Committee Chair Thall presented the minutes provided to the Committee.

Motion:

By motion that was moved and approved unanimously by Committee members, it was;

RESOLVED: That this Committee approved the meeting minutes from the June 8, 2021, meeting.

5. <u>Special Presentations</u> – None

6. <u>New Business</u>

Action 1 - Independent Internal Control Audit – Procurement Discussion – Ms. Lynn reviewed the requirement for SERS to undergo an internal control examination, or Service Organization Control (SOC 1, Type 2) audit, as mandated under Act 2020-128 effective November 2020. This legislation requires both PSERS and SERS to undergo a SOC audit every five years. Staff's recommendation to the Committee is that this audit take place during calendar year 2024. This timing will meet the Act's requirements while also allowing for the July 2022 implementation of SERIS 2.0, the subsequent stabilization of the system, and for staff to learn how to effectively utilize the system.

Speaking on behalf of the Committee, Chair Secretary Thall agreed with staff's recommendation to plan and budget for a SOC audit in calendar year 2024. Accordingly, Internal Audit will draft a Request for Proposal document in the future to meet this timing.

Action 2 – Review of Draft Policy – Rotation of Independent Audit Partner – Ms. Lynn reviewed a draft policy on implementing rotation requirements for SERS independent audit



partners. This policy was drafted to address questions raised by Board members during a procurement effort for independent auditor services for 2021-2025. At the evaluation committee meetings, discussion took place concerning the fact that the selected firm, KPMG LLP, was awarded the contract and will be serving SERS for a continuous 10-year period.

Chair Secretary Thall and Ms. Soderberg agreed with the intention of the policy to ensure independence as well as allow for a fresh perspective to the SERS independent audit engagement. As a result of the discussion, the policy will be further developed for review by the Committee at a future meeting for possible recommendation to the Board for action.

Action 3 – Internal Audit Office Update – Ms. Lynn reported that Item 5.2 of Funston's Fiduciary Review report was tagged to the Audit, Risk & Compliance Committee and recommended that "This Board maintain oversight of cybersecurity performance and risks." SERS cybersecurity program was discussed at this meeting by SERS IT officers in executive session and will be reported on periodically at future meetings.

It was also mentioned that Internal Audit's IT Staff Auditor has accepted a position in SERS finance area and will be transferring effective November 6th.

Action 4 – Schedule of Employer Allocations and Pension Amounts by Employer as of December 31, 2020 (GASB 68 Report) – This report was provided as an informational item only.

7. <u>Executive Session</u>

At 4:00 p.m., the Committee then entered into executive session to review and discuss committee business which, if conducted in public, would violate a lawful privilege, or lead to the disclosure of information that is confidential or protected by law. Action 1 – Internal Audit Staff – The draft policy regarding establishing a periodic rotation for SERS independent audit partners will be presented to the Committee for possible recommendation of the policy to the full Board for action.



Action 2 – Bureau of Information Technology Staff – Robust discussion took place on the cybersecurity program being developed by SERS Chief Information Security Officer. Although no direct action was requested of Bureau of Information Technology staff, the topics of discussion (cyber insurance, identity of cyberattack instances occurring at SERS, plans to address existing vulnerabilities, etc.) will be taken into consideration for future presentations.
