### 1. Call to Order

Chair Soderberg called the meeting to order at 1:30 P.M.

# 2. Welcome and Roll Call

Brenda Cunard, Deputy Executive Director for the Office of Member and Participant Services, conducted a roll call of the Committee members and designees. Chair Soderberg also welcomed new Committee members Acting Secretary Wendy Spicher and her designees Seamus Dubbs, Eric Pistilli, and Jeffrey Soderstedt.

# 5. Special Presentations

# a. Investment Rate of Return Actuarial Assumption

• Chair Soderberg announced that SERS' investment consultants from Callan and SERS' actuaries from Korn Ferry were attending in person to present the annual Investment Rate of Return Actuarial Assumption. After both parties presented their material, Chair Soderberg stated that she is comfortable keeping the Assumed Rate of Return at its current rate of 6.875%. The Committee members unanimously agreed; therefore, no motion was necessary.

#### 6. New Business

### a. OFM Update

• Chief Financial Officer Sara McSurdy presented high-level financial highlights from the December 31, 2022 year-end financial statements for the Defined Benefit Plan, Defined Contribution Plan, and Deferred Compensation Plan. Her presentation focused on contributions, investments, and benefit payments for the various plans. She thanked OFM staff for their efforts on the statements and audit. She concluded by recognizing Chair Soderberg for chairing the Finance and Member and Participant Services Committee since its inception in 2019.

## b. OMPS Update

 Deputy Executive Director for the Office of Member and Participant Services (OMPS) Brenda Cunard presented some highlights within OMPS. She began by providing a breakdown of enrollment of members and participants within the various classes of membership. She also reported that OMPS staff have experienced an increase in the number of benefit estimate requests but not an increase in requests to sign retirement applications, in anticipation of the current



collective bargaining agreements, which will expire June 30, 2023. She announced that the Department of Corrections has invited SERS staff and representatives from Empower to speak at new employee orientation sessions, noting that the initial session was successful in compelling new members to file a beneficiary form with SERS. She also reported that retired Harrisburg Regional Counseling Center Manager Joe Fleming's vacancy has been filled by Ms. Allison Ebersole. Ms. Cunard concluded her presentation by highlighting the 2022 Actuarial Report for the Defined Benefit Plan and the Benefits Completion Plan produced by Korn Ferry.
