The Investment Committee supports a \$300 million commitment pacing level to non-core value-add/opportunistic real estate funds in 2024. Mike Elio of StepStone Group, LP provided the Investment Committee with a pacing update and strategic investment plan recommendation for SERS' Private Equity and Private Credit portfolio. The Investment Committee supports a \$800 million commitment pacing level to private equity in 2024.
