6. <u>New Business</u> – Mr. McCoy and Ms. Tronetti presented an Introduction to the Institute of Internal Auditors' updated Global Internal Audit Standards, which take effect in January 2025. Upon commencement of their presentation, Mr. McCoy informed the Committee that they could find a full version and a condensed version of the Standards, for their review, under agenda item 6A in BoardDocs. He also noted that there was an updated Internal Audit Office Charter included in BoardDocs under agenda item 8B as an informational only item for review, which will be voted on for Board recommendation by the Committee after a discussion at either the February or April 2025 meeting.

Next, Eric Forkner and Craig Swallow, both partners with SERS' external audit firm KPMG, provided the audit plan for the agency's upcoming 2024 independent financial statement audit. They explained their required standards, their responsibilities as it relates to controls, their audit methodologies, and confirmed their independence with the Audit, Risk and Compliance Committee.
