Definitions:

Carried Interest – The general partner's share of the profits generated through a private equity fund.

Management Fee – The annual fee charged to limited partners to cover the basic costs of running and administering a fund.

Manager Operating Expenses – These expenses include, but are not limited to, operating and other recurring expenses such as legal and audit services.

Performance Fee - Performance fees are fees paid to a manager for exceeding certain performance thresholds. The calculation methodology is described in detail in each fund or separate account's legal documents (e.g., partnership agreement or side letter). Performance fees may be paid on a "rolling" basis for open-end funds or separate accounts, and are commonly paid by closed-end funds as investments are realized.
